




Dr N Kumaraswamy, Dean of Academics also welcomed the JNTUK Nominee, Principal, Dean of Studies, Heads of Departments and other Academic Council members.

The following items of the agenda were discussed and resolved by the Academic Council.

RESOLUTIONS:

Item-1: Approval of Academic Report 2019-20 of the college

Resolution-1: Dr Y Mallikarjuna Reddy, Principal presented the academic report of 2019-20 and the members approved it.

Item-2: Approval of constitution of Board of Studies for new B.Tech programmes from the Academic Year 2020-21

Resolution-2: All the Board of Studies Committees for new B.Tech programmes constituted as per AICTE/UGC/JNTUK norms were approved. All members were expressed their happiness for securing four new B. Tech programmes in emerging areas, namely Artificial Intelligence & Data Science (AI&DS), CSE (Artificial Intelligence & Machine Learning) (AI & ML), CSE(Internet of Things) (IoT), and CSE(Internet of Things & Cyber Security including Block Chain Technology) (IoT &CS BCT) from the AY 2020-21.

Item-3: Approval of R&D activities for the AY 2019-20

Resolution-3 Dr K Giri Babu, Dean of Studies, presented the R&D activities of various departments indicating the funds mobilized from various governmental agencies and the members approved it.

Item-4: Approval of Minutes of the External BoS meetings for II year B. Tech programme under R-19 regulations and for PG programmes

Resolution-4 Heads of Departments of CE, EEE, ME, ECE, CSE and IT presented the minutes of their respective External Board of Studies meetings held and the suggested syllabus and curriculum for II Year B. Tech programme (AY 2020-21) for students of Autonomous branch under R-19 regulations. Also it is resolved that JNTUK curriculum and course structure will be followed for all PG courses.

Item-5: Approval of First year syllabus and tentative course structure for newly incepted B. Tech programmes in emerging technologies

Resolution-5 Dr M V Raghu Ram, Head, Dept of S&H presented the first year course structure of CSE under R-19 regulation that would be implemented for the four new B. Tech programmes in AI&DS, CSE (AI & ML), CSE(IoT), and CSE (IoT &CS BCT)for the AY 2020-21 and the council approved it.

Item-6: Approval of Placement activities data for AY 2019-20

Resolution-6 Mr. T Srinivasa Rao, Head, Training and Placement Cell presented statistics about the placements secured for the AY 2019-20 and the plans for future roll outs and student training and it was approved by the members.

Item-7: Approval of implementing R-20 Regulations for B.Tech with Honors / Minor degree with effect from AY 2020-21.

Resolution-8 Only B.Tech First Year first semester results were announced. Due to COVID-19, other exams are not yet conducted. Mr. P. Ammi Reddy, COE, Exam Cell presented statistics about the B.Tech First Year first semester results and it was approved by the members.

Item-9: Submission of 4th report of AQAR for the Academic Year 2019-20 to NAAC.

Resolution-9: Due to COVID-19, the Affiliated University (JNTUK) has not yet conducted the semester end examinations for the Academic Year 2019-20.

It is resolved to submit 4th report of AQAR to NAAC for the Academic Year 2019-20 after publishing the Academic results of semester end examinations for the Academic Year 2019-20.

Finally, the Academic Council resolved that any uniform/common regulations for Autonomous colleges suggested by the university in future, the approved regulations will be discussed and modified appropriately.

Dr L. Suma Latha, appreciated the efforts for getting four new B. Tech programmes in emerging areas.
