Sri Vasireddy Vidya Sagar, Chairman of the Governing Body & Social Educational Trust chaired the meeting and initiated the Proceedings with a warm welcome to Dr. Ch. Sai Babu, Prof, EEE, Dept. JNTUK, Kakinada & State Govt.(APSCHE) Nominee, Industrial Experts, Educationists and other members of the Governing Body.

The principal of the college welcomed all the honourable members and presented the agenda items of the meeting for consideration, approval and suggestions from all the members of the Governing Body.

The following items of the agenda were discussed and the resolutions were passed unanimously by the Governing Body.

### **Resolutions**

**Item -1:** Approval of the minutes of Academic Council meeting held on 03-10- 2020.

**Resolution-1:** The Governing Body resolved to ratify the minutes of the Academic Council Meeting held on 03-10- 2020 with necessary instruction for effective implementation in Toto including R-20 Regulations for B.Tech with Honors / Minor approved by APSCHE.

They expressed their happiness for securing four new B. Tech programmes in emerging areas, namely Artificial Intelligence & Data Science (AI&DS), CSE (Artificial Intelligence & Machine Learning) (AI & ML), CSE(Internet of Things) (IoT), and CSE(Internet of Things and Cyber Security including Block chain Technology) (IoT and CS including BT) for the AY 2020-21.

The Governing Body members also expressed their satisfaction with the placements facilitated by the Training and Placement Cell of VVIT and suggested to improve the placements in core sector.

**Item -2:** Approval of Staff recruitment for various departments

**Resolution-2:** The Governing Body has noted the current faculty position and staff recruitment by Staff Selection Committee for various departments. The existing faculty in various departments has increased to 286 for the AY 2020-21 in line with AICTE/JNTUK norms.

**Item -3:** Approval of Project Proposals submitted to DST & AICTE

**Resolution-3:** Dr K Giri Babu, Dean of Studies, presented the R&D activities of various departments indicating the funds mobilized from various governmental agencies. Existing R&D projects funded by Government agencies were reviewed and the members felt that senior faculty should get more funded R&D projects. Also the Governing Body suggested that more focus on quality publications and patents is necessary. Dr Sai Babu suggested to increase the DST proposals especially, from CSE department
